2. Summary of Proceedings	Action Points
1. Opening and updates: The RCO welcomes partners. Then a short update on the conclusion from the UNCT Retreat took place stating that the UNCT retreat in August 2017 requested the instatement of a Humanitarian – Development (HD) nexus working group which will consist of members from UNDP, IOM, OCHA, WFP, WHO, UN Women, UNESCO, WMO, UNFPA, UNHCR and UNICEF. This meeting is the first meeting of this group. The agenda was then briefly explained. The WG will give guidance and practical advice and support on how to advance the NWOW agenda in Nigeria.	-
 2. Presentation and endorsement of the WG ToR: The Transition and Resilience Advisor to the RC briefly recapped the NWOW and the developments at the global agenda with regards to bridging the humanitarian-development nexus. The draft ToR was presented and following points were discussed: The key elements of the ToR are to: sensitize agencies about the NWOW and the HD nexus; identify what is there and mobilize knowledge within the agencies; and identify and share experiences within and outside Nigeria; recommend pilot interventions and partnership strategies; With regards to the specific deliverables in the ToR, the following points were suggested: Deliverable No. 3 should be amended to ensure a) that there is an inventory made of ongoing initiatives and b) how joint analysis and planning can be strengthened. Furthermore, the point needs to reflect the need for widely sharing that information between the agencies and not only collecting it. Deliverable No. 4 should also ensure 	The ToR will be reviewed and the revised draft is to shared with the group (responsibility RCO and OCHA focal points)

	linkages between the initiative currently being set up as a recommendation from the UNCT retreat and requires additional emphasis. <u>Deliverable No. 5</u> should also capture that guidance is needed on how and under what forms the WG should interact with other partners.	
•	Way forward: A number of issues were discussed under this agenda item. The WG requires strong agency commitment and it is crucial that all agencies are present. Therefore, individual follow-up with each nominated agency will take place. There also needs to be an understanding that the membership in the group requires work. The different capacities of the various agencies should be taken into consideration and it needs to be ensured that the group functions as an added value to agencies rather than a burden. To balance the workload, it has been suggested that a core group will carry the larger part of the work.
